

Keep in mind you're representing Oxford House as a whole during this entire event, we are asking for everyone to have patience and to act responsibly.

DO NOT SMOKE OR VAPE in your hotel room or anywhere else inside the hotel. Please smoke in designated smoking areas only, away from doorways, on the west side of the hotel, along or near the river. Please do not smoke in front of the hotel.

A breakfast & light dinner are provided by the hotel on the mezzanine level for hotel guests only. Those not staying in the hotel will need to make other eating arrangements, as these meals will not be available for purchase.

A Hospitality Room with light snacks and refreshments will be available to all conference attendees. This will be located across from the Bosin Ballrooms, upstairs in the Siedhoff Salon. Note that this room will be closed during sessions.

Oxford House Swag Tables are located outside of the Bosin Ballroom, we will have approximately 6-8 tables to share amongst the entire state, so please be respectful of space, first come first serve. Each house and chapter are responsible for monitoring its own swag and funds, as well as clean-up afterwards. Swag will not be available during sessions.

Raffle Tickets will be sold throughout the convention and items raffled off on Saturday evening. We will have a variety of different raffles going on for a variety of different items; gift cards, electronics, televisions, a tattoo session, E.E.S. & more!

A small market with snacks and beverages is available for purchase behind the hotel front desk, you will need to pay for items at the front desk.

An ATM is available inside the hotel, behind the hotel front desk. Surcharges may apply.

Parking – Garage parking is available, you will need to check in at the front desk to pay for parking, up to \$12 per night for overnight parking. For daytime parking \$0.00 for 30 minutes, \$1 for 31-60 minutes, \$0.75 for each additional 30 minutes, up to \$12 per day. There is a parking lot to the north of the hotel, it is \$4.35 per each 24-hour time period, however, you will need to download “ParkMobile”, and

link a payment source such as Visa, American Express, Master Card, or Discover & you will also need to know your license plate number.

Keep in mind there is limited free street parking available, so plan accordingly.

Free Wi-Fi is available for convention attendees through the Drury Hotel. No password will be required to connect to the hotel's Wi-Fi.

Kady Stevens is a resilient and compassionate woman who has transformed her challenges into a powerful commitment to helping others. After a short-lived stay in the Hays women's Oxford House in October 2020, Kady had a return to use for several months. But she then completed treatment and reintegration in the spring of 2021. That's when the recovery really started. On May 18, 2021, she moved into a women and children's Oxford House in Topeka, where she lived for nearly seven months and took on various house positions.

Recognizing the need for replication, Kady moved back to Hays to assist the Amaryllis West Oxford House, which had dwindled to just two members. Her dedication was quickly acknowledged as she was elected chapter co-chair, and shortly after, she stepped into the role of chapter chair. Kady also served on the state association as the Budget and Finance officer for a term. After six impactful months, she moved out of Oxford House to regain custody of her son and transitioned into an Alumnus role. During the next elections she was elected to serve as chair of the alumni association in her area. After the geographical split of the Alumni association, she was elected to serve as the Chapter XX Alumni treasurer. Her continued contributions earned her the title of Chapter XX Alumni of the Year in 2024.

As a devoted wife and mother of two boys, Kady draws her strength from God and her faith. She now has over three and a half years of sustained recovery. In addition to her personal journey, Kady has been actively involved in advocacy. Since May 2022, she has worked tirelessly at Options Domestic and Sexual Violence Services, supporting survivors of domestic and sexual violence. She also began working with FORA in May 2022 as an outreach coordinator for Barton and Ellis County. Recently, she became a Kansas Certified Peer Mentor (KCPM) with Smoky Hill Foundation in November 2023, further expanding her ability to connect and inspire others on their paths to recovery.

Joshua (Huggie) Huggins moved into Oxford House in Montgomery, Alabama in December 2018 and spent nearly two years as a resident. During this time, he not only embraced the recovery process but also played an active role in expanding the Oxford House network. He helped open multiple houses and became Alabama's first State Chair, helping lay the groundwork for the organization's growth in the state. After moving out of Oxford House, Huggie was instrumental in founding the Alabama Alumni Association, providing a support network for those who had moved out of the houses but still wanted to stay connected to the recovery community. In 2021, Huggie was elected as Alabama's first World Council Alumni Candidate. His dedication and leadership skills led to him being elected as a one-year alternate member of the World Council. The following year, he ran for a full three-year term and became Alabama's first World Council Member. During his time on the World Council, Huggie held several key leadership roles: Alumni Committee Chair, Vice-Chair of the World Council, Chairperson of the World Council (2023–Present). As part of his work, Huggie played a pivotal role in creating the first-ever National Alumni Conference Committee, which is planning the first National Alumni Conference to take place in spring 2025. Additionally, he helped develop the Alumni Association Common Practices Document, which will serve as a guide for new alumni associations in the future. Despite his national responsibilities, Huggie continues to serve in key positions, including as Vice-Chair of the Alabama Alumni Association. His leadership on the World Council and his dedication to the growth and sustainability of the alumni network have made him an invaluable figure in the Oxford House community.

My name is Danny Fryhover my sobriety date 10/1/18 I lived in Oxford House for 4 years. I held just about every position in a house, in housing services and was treasure for 2 years and male co-chair of Chapter 7. I've been to world 3 times. I am an alcoholic and drug addicts. My drug of choice was methamphetamine. At the age 47 I was homeless for a year and a half spent most of 2017 and 2018 in jail. Was facing multiple felonies and multiple counties. When I entered Oxford House I had a job and that was it I was on paper and five counties. In my four years in Oxford House I paid off over \$30,000 in debt, got my license from the state back after 3 years suspension, was promoted to machine shop manager over to different plants. Successfully got a relationship back with my children and my extended family. Joined Oxford Alumni Association last October and currently co-chair of Oxford Wichita Alumni Association. I am also an active member of AA and have several sponsees that I work with regularly.

My name is Marlin Guest. I am a person in long-term recovery. What that means to me is that I have not found it necessary to use any mood or mind-altering substances since May 18, 2020. I spent my first 18 months of recovery in the Crossroads Oxford House. I now live in Oxford House Jonah, which I opened with help from Samuel Smith on November 15th, 2021. Since being in Oxford, I have served as Chapter 2 Housing Services Chairman and Chapter 2 Chapter Chairman. I am currently the Chapter 2 Parliamentarian and KOHSA Housing Services East Chairman. On May 15th, 2024, I will graduate from Washburn University with my addiction counseling degree. I currently work at Valeo Rehabilitation Center as an alcohol and drug technician. I owe everything good that is happening in my life to God, Oxford House, a host of family and friends in and out of recovery. Very truly I tell you, if it were not for God, through Oxford, I would not be sober today.

Mark Spence, NCPRSS (National Certified Peer Recovery Support Specialist) was born and raised in Washington DC. He is a coach, mentor, speaker, recruiter, spiritual leader and ambassador for Recovery. Mark has been clean and Sober for over 35 years! He has traveled to over 20 states and the US Virgin Islands opening up Oxford Houses and in doing so has helped changed countless number of addicts lives. Mark has been featured on local and National TV, Cable, Radio stations, articles and publications sharing his story trying to educate and empower others they too can live without drugs and alcohol.

In 1988, Mark moved into the 8th Oxford House that existed on Bellevue Terrace in Washinton DC and it remains open today. In 1989, Mark was hired by Paul Molloy, the Founder of Oxford House, as a National Outreach Worker. In that same year, Mark opened his first house in DC; Oxford House Jonquil. In August 1990, Mark opened the first Oxford House in the state of Washington in Edmonds. The community didn't want the opening of Edmonds house and this case went all the way to the Supreme Court for NIMBY which stands for; Not In My Back Yard. The Edmonds house remains open and active today 34 years later. In May 1991, Mark appeared on 60 Minutes TV show that aired on the CBS network telling his story. Twenty-five years later, he was invited back on the Meredith Vera show to celebrate how the Oxford House concept was still growing. In 2022/2023, Mark was featured in a public service announcement called "My Recovery DC" that was inserted during commercials that ran on the local networks and cable stations in DC. In 2024, Prosperity Media, a Washington based award winning nonprofit organization which highlights the good in humanity, interviewed Mark on their Solutions program that aired on Montgomery Cable TV in January.

Mark earned a Bachelor of Science degree in Banking and Finance at Wheeling College in 1983. Two years later, Mark joined the Army Reserves. He holds a seat on the Board of Directors for Salvation Army's Adult Rehabilitation Center. Mark is a prominent member of St. Martins Catholic Church which serves the NA and AA community. He is pictured on a Historical African American Heritage board that stands outside of St. Martins Church. Mark continues to be a Proud member of NA, a man of service, opening up Oxford Houses in D.C. and Prince Georges County Maryland. Mark's life mission and service is to uplift, inspire and encourage addicts that we can live one day at a time which can turn into a lifetime.




