Budget and Finance Report

The Budget & Finance Committee met a couple weeks ago and finalized this year's Budget Proposal. I have laid out several copies of the 2025 Budget Proposal. Please use those as a reference as I give my report.

State Meetings: \$16,300 Budgeted , Line items in this category include-

- Hosting Donations-\$100 spent of the \$600 allocated for the year.
- Food Expenses- \$500 spent of \$4,500 allocated for the year.
- Travel Expenses-\$487.12 spent of \$10,000 allocated for the year.
- Transfer to Savings-\$200 transferred to savings of the \$1,200 allocated for the year.

IT: \$2,400 Budgeted Bi-Monthly Payment-\$400 has been spent of the \$2,400 allocated for the year. The cost of Word Press/Hosting Fee will not be a part of this year's budget. Since a 2-year plan was purchased at the end of 2024. I only mention this for replication's sake, because \$400 will need to be added the 2026 Budget next year to cover that expense.

Chapter Donations (Emergency Situations): \$11,000 Budgeted, we have spent \$1,272.36 of \$11,000 allocated for this category. \$1,272.36 was used out of this category last meeting to cover James McClain's travel expenses For the Alumni Conference held in Wichita.

Unity Events: \$4,000 Budgeted, we have spent \$0 of the \$4,000 allocated for this category.

World Council: \$14,000 Budgeted, Line items in this category include-

- World Council Travel- We have spent \$12,000 of the \$12,000 allocated for travel. Which includes \$6,000 to each World Council Member.
- World Council Campaign- We have spent \$0 of \$2000 for the delegate selected to run for the World Council Alumni position at this year's World Convention.

4TK: \$16,000 Budgeted, we have spent \$0 of \$16,000 allocated for. This category has been increased by \$2,000 so that we can Include Pittsburg to this year's donation. The following is the list of areas that will receive \$2,000 each for their local 4TK events. Wichita, Kansas City, McPherson, Hays, Hutch, Great Bend, Pittsburg and Topeka.

Conventions: \$75,000 Budgeted Line items in this category include-

- State Convention- We have spent \$0 of \$50,000 allocated for.
- World Convention- We have spent \$0 of \$25,000 allocated for.

Out of State Donations: \$10,000 Budgeted Line items in this category include-

- Emergency Situations-We have spent \$0 of \$5,000 allocated for.
- Natural Disasters- We have spent \$0 of \$5,000 allocated for.

As of January 1, 2025 we had a total of 211 houses with 1,813 beds. At \$6 per bed monthly, our projected income from bed dues this year is \$130,536. That doesn't include income from houses that have opened since or will open throughout the upcoming year. We had to increase certain line items this year to meet the needs of our growing State. Keep in mind we did receive \$46,309.62 back from the \$50,000 we spent on last year's State Convention. So, we added \$18,164 of that \$46,309.62 as Compensation to meet the need. The rest of last year's State Convention refund will remain in our reserve.

We have spent a total of \$14,959.48 of \$148,700 Budget for the year.

I want to thank Alex Lewis, Stephanie Fillmore and Brian Holmes for being of service on this year's Budget & Finance Committee.

That concludes with the Budget and Finance report. I have given the secretary a copy of my report to add to the minutes. I now would like to ask the State Association to accept the 2025 Budget as Presented.

Re-entry Report

We have accepted 39/75 applications for the month of January for a 52% rate and accepted 30/60 for February for a 50% rate, for a total of 69/135 for a combined acceptance rate of 51%. Our Checking account balance is \$4521.30, and our Savings balance is \$990.39. We have funded 144 Re Entries since 2023 for a total of \$21,435.00.

Our current Fundraiser is going to be Reentry T-Shirts, Bracelets and a possible T.V. Raffle which will be announced as soon as we have all merchandise available to purchase. Our monthly Committee Meeting is currently the first Saturday of every month at 8AM. via messenger video chat. Other information to be noted- Currently myself and the committee are working on a Reentry Manual/Pamphlet regarding providing information on the Reentry process, how it works and replication to those curious about the program. Also working on an informational Packet/Pamphlet for institutions to disperse among Caseworkers/Unit teams and inmates alike on how to go about applying for Reentry and what Guidelines and Expectations need to be met to Qualify. Also in the works, there is a Reentry Funding Request Form which will be available to houses when complete.

World Council Report

The chapters and associations committee is still working to gain attendance. The members that join are still mostly from Kansas so thank you all who do attend. We got some good input at this recent meeting. I think we finally have a solid idea of what we are going to work on the next few months and at the summit. The idea is to come up with some sort of plan to get members to stay at least 18 months in oxford. At the summit we plan on hopefully making some sort of document to distribute to all of oxford. This should include all that stats that show how much higher chance you stay a member has to stay clean after 18 months in oxford. Soon we plan on reaching out to alumni members and asking them what goals they wish they would have worked on while living in oxford. The idea is to come up with a list of goals and resources that a member can work on while they live in oxford. This is a brand-new idea, and we are still not exactly sure what it will look like.

Our chair says it is very normal for new Council members to be confused about what to do during the months leading up to their first summit. With so many members stepping down this year us new council members have lacked good guidance and replications. We plan on

working on a new member packed for new council members to give them a better idea of what to expect their first year. At the summit each committee will develop a set of goals and actionable items to work on. I should have a much better idea of what is going on at the next State meeting.

Big news for Oxford House! In celebration of our 50 year anniversary OHI is making a brand-new documentary about Oxford House! This is very exciting! OHI already has the production crew and an outline, and they are ready to start filming once funds are raised. The total cost will be between \$160,000 and \$175,000. They are asking each state to donate \$5000 and chapters and houses to donate what they can.

Since January I have attended the alumni convention and the Missouri state convention. Lots of travel coming up soon. I plan on attending the Oklahoma Conventions then I have the Summit in Arkansas then immediately after that I plan on going to the Florida convention! Thank you for all your support. I am excited to learn a lot during my travels and bringing the fire back to Kansas.

Things to Ponder and Helpful Tips:

When moving into an Oxford House, try to focus on making your transition out goal-oriented rather than based on a strict time limit. Many individuals come in with the mindset of *"I'll only be here for six months,"* but recovery and stability don't always fit into a set timeline. Instead of focusing on a specific timeframe, take the time to read the manual, actively support the newest members in your house, and set achievable goals that will prepare you for long-term success. Moving out should be a milestone based on readiness, not just the passage of time.

One thing I really want to emphasize today is this:

Think about the quote, *"Are we meeting the need?"* But I don't just mean in terms of how many beds we have. Instead, are we truly meeting the needs of the individuals we are currently serving?

In a week and a half time span, we lost three of our own in houses across the state. That is a heartbreaking reminder that we are falling short in supporting our fellow family members. So I ask, how often are we really checking in on each other? Are we taking the time to truly listen when someone speaks? Is your house fostering unity through events and

connections? Are you doing personal check-ins after every weekly meeting? What does each person's recovery plan look like? Is recovery thriving in your home, or is it lacking?

Another concern I've noticed across the state is people using their positions of leadership in the wrong way. Holding a role, whether it's as a president, chapter chair, or state leader, does not mean running the show alone. Our success comes from being democratic, from working together, and from leading with guidance rather than control. Leadership is about lifting each other up, not exerting power over others.

Yes, there will always be a need for more houses and more beds, but this is not a race. Our priority must be the people already in our homes. If we aren't supporting ourselves and our current members, then we aren't truly helping anyone. Let's slow down, refocus, and commit to doing better, for each other and for the future of our community.

Important Reminders & Updates

1. Inspections & Entry Rights

If someone comes to your house claiming they need to perform an inspection, you are not required to let them in unless it has been coordinated with the landlord and the house. Inspections for single-family homes are not standard practice, and the same applies to Oxford Houses. Unless they have a warrant, you have the right to deny entry.

2. Treasurers & Check Signing

In the treasurer duties updated by OHI it states "The treasurer will write checks for all house approved expenditures and will not be one of the duly authorized officers designated to sign checks."

3. Audit Training & Financial Responsibility

Kansas City is hosting an audit training on March 29th at the FORA office from 9 AM to 5 PM. It is crucial that audits are conducted within houses and chapters every month when bank statements arrive. Regularly reviewing financial records ensures accountability and smooth operations. Please consider arranging audit training in your area. If you need assistance, FORA is here to help!

4. Membership Voting Protocol

When an individual is not accepted, the only response that should be given is:

"I'm sorry, you did not receive an 80% vote."

5. Back to Basics

Take time to revisit the fundamentals and learn the model. A strong foundation ensures success!

A landlord of one of our womens houses, Oxford House Robin, has decided not to renew the lease and has given the house a 30 day notice, they have until April 21st, which is 30 days after their lease is up to vacate the premises. The landlord has stated that he would like to sell the house and we are in talks with investors about purchasing the house so we might be able to keep it open. This has happened a month and a half after we had to restructure the house. The ladies have come a long way and are doing much better!

A couple months ago we motioned to open a new mens with childrens house, but we are struggling to find properties and investors/landlords so that we can open said house.

The other womens house in our chapter, Oxford House Parkplace, was also struggling with bullying, campaigning, financial issues, and not holding their members accountable, but after chapter stepped in to help, the house has done a complete 180 and they are doing great!




