Budget and Finance Report

State Meetings- We have spent a total of \$12,234.28 of \$16,300 Budgeted

Line items in this category include

Hosting Donations-\$500 spent of the \$600 allocated for the year. Which includes \$100 donated to Chapter 24 at the last meeting in Salina.

Food Expenses- \$3,500 spent of \$4,500 allocated for the year. Which includes \$750 allocated to Chapter 24 at the last meeting.

Travel Expenses-\$7,234.28 spent of \$10,000 allocated for the year. Which includes \$729.26 from the last meeting.

Transfer to Savings-\$1,000 transferred to savings of the \$1,200 allocated for the year. Which includes \$200 from the last meeting.

IT: We have spent \$2,000 total of \$2,400 Budgeted

Which includes the \$400 bimonthly payment from the last meeting.

Chapter Donations (Emergency Situations): \$6,272.36 spent of \$11,000 Budgeted

4TK: We have spent \$0 of the \$16,000 Budgeted

Since this line item will more than likely be distributed today. The 8 areas that have been budgeted to receive \$2,000 each for their 4TK events include- Wichita, KC, Topeka, McPherson, Hays, Hutch, Great Bend, and Pittsburg.

Conventions: We have spent \$59,384.63 of \$75,000 Budgeted

Line items in this category include

State Convention- We have spent \$35,000 of \$50,000 budgeted. I will mention, there were some Chapters that wrote their convention checks to KOHSA last meeting, which totaled \$1600. That \$1600 was paid out to the Alumni Association that is handling the finances of our state convention. I mention this because that amount will not reflect in our budget.

World Convention- We have spent \$24,384.63 of \$25,000 allocated for. Which includes \$2,025 sent to OHI to cover the balance owed for the World Convention.

Out of State Donations: We have spent \$5,000 of \$10,000 Budgeted

Line items in this category include

Emergency Situations-We have spent \$0 of \$5,000 budgeted.

Natural Disasters- We have spent \$5,000 of \$5,000 budgeted.

We have spent a total of \$101,654.66 of \$148,700 budgeted for the year. Which includes \$4,204.26 allocated out of this years budget at the last state meeting.

The State Association Meeting Minutes have been formatted and unloaded for your review along with the agenda for the state meetings to the website. Updates have been made to the Contact Page.

I've updated the state convention page on the website, which included the banner the Program for the State Convention.

Still working on page updates to include the PDF's of all of the forms, hope to have that rolled out soon.

The statistical data regarding webpage views and visitors is remaining constant during both of these reporting periods. The website received 9,055 view in July and August, which is up by 395, the two months prior. Hello Family,

On the 2nd of November we had our first full business meeting since the world convention. Since this was the first real meeting there was a lot of replication happening and “passing the torch” so to speak from former committee chairs to the new chairs. The meeting started off with a pretty good motivational speech from our World Council chair Cherie. She highlighted 3 key points she would like the council to focus on for the next year.

Strengthening Communication: Ensuring transparency and open dialogue among members.

Enhancing Collaboration: Encouraging cross-functional teamwork.

Focusing on Impact: Aligning our efforts with our mission.

Cherie is already showing us that we made a good choice for chair, she has been attending all our committee zooms and is taking a very hands on approach.

Charter Committee: Has been continually working with houses and chapters to get their charters and helping them with whatever information they may need.

Chapters & Associations: I am the current chair of this committee. We have been working on and have almost completed a short presentation that focuses on getting members to stay longer in oxford house. This presentation will include data from the DePaul studies and it will include common goals for members to set and all the good reasons to stay a little longer and also some common reasons that members move out too soon.

We are looking forward to completing this goal and then focus on finding another goal that will help oxford house.

Engagement: Working on content for the next publication of The Common Good newsletter. Brandie and Jose have also been working on strengthening unity between chapters and associations in their respective areas.

Networking: Discussing their plans for what the committee will be working on moving forward. They have currently been collaborating with OHI and drug courts and treatment centers in Illinois to promote Oxford House within the area.

Technology: Working on reaching out to companies and business to get discounts and free resources on computers and applications for Oxford House.

Environmental: Brainstorming ideas on what areas they should focus on. Currently working on furnace filter/ smoke detector logs for houses to help ensure houses are checking them on a regular basis. I also think they are still working on emergency preparedness ideas for houses.

Alumni: Working on the National Oxford House Alumni conference which is coming up in a few months on valentines weekend right here at the Drury hotel. They are also brainstorming what the 2027 Alumni event will look like.

So unfortunately we have lost our first member since the convention. Brett is no longer with us and Alex from Chicago will be stepping up into his voting position and also his Networking committee chair position. Page from Oklahoma will also be taking on the secretary position in place of Brett.

For my recent World Council travels i was asked to go talk to South Dakota about being a member driven state. I had a phone conversation with their local OHI employee and he had stated that there were only 2 employees for the whole state and he would like us to do a presentation about being member driven and for houses and chapters to not be so reliant on OHI. I asked Alex and Buster to go with me and i think we all thought we did a pretty good job. Unfortunately there was some mis communication or misunderstanding between some of the staff that were present. I had to explain that our presentation was not meant to be anti OHI and explain what exactly we had been asked to talk about. All in all we other wise got pretty good feedback from the local members.

Also i finished the last of the \$6000 the state provided me for my travels and have turned in an accounting of what it was spent on to Buster. Im looking forward to this next year and hope to keep kansas updated on what happens in Oxford House across the nation.

2. Funding Support – Address rent, move-in fees, and pending checks (Sunset Hills, Layton, Kiowa, Chautauqua).
 - i. Layton check was mailed, and it was received after 12 days.
 - ii. Kiowa check was mailed on 10/6/2025
 - iii. Sunset Hills outreach coordinator has been informed of their request for assistance. Once the details of the need are submitted to us, we will address how we can help them.
 - iv. Chautauqua has a sense of humor.
3. Supplies & Resources –
 - a. Beds (Halina, Sunset Hills)
 - i. We will be reaching out to the outreach coordinator in this area to find out if the beds in our storage will help with this request.
 - b. UA cups and clarity on false positives (Chaparral, Faith, Halo)
 - i. Chaparral was contacted and given the protocol for false positive UAs.
 - ii. Faith was out of UAs. Outreach Coordinator from that area picked up monthly UAs to take to Topeka Houses.
 - iii. Halo does not currently buy UAs from FORA. A follow up email was sent asking if they are interested in purchasing UAs from FORA instead of their current supplier.
 - c. Narcan (Washburn)
 - i. 2 boxes of Naloxone were shipped to Washburn last week.
4. Housing Concerns – Mold issue at Peace House (escalate with landlord).
 - i. I have personally been working with Laura to escalate this with Peace's landlord. House may have to move laterally if the landlord doesn't fix the issue.
5. Form & Reporting Improvements –
 - a. Add multiracial and Asian options (Iris, Justus).
 - i. This is being added to October's Monthly Report.
 - b. Consider simplifying the monthly reporting process (noted as "excessive" by Big Creek).
 - i. Follow up email sent to explain the reasoning for the monthly report and the importance of the data.
6. Training/Support – Provide replication training materials for new members (Paidia).

- i.This is a project that the Outreach Coordinators have been working on. And they plan to roll this out in November.
- 7. Scholarships & Opportunities – Explore funding options (October).

Monthly Peer-Led Support Group Series at Friends of Recovery Association (FORA)

This will be called FORG (Friends of Recovery Groups)

Purpose - To propose the establishment of a rotating, weekly peer-led support group series at Friends of Recovery Association (FORA), offering a diverse and inclusive space for individuals and families in recovery. This initiative would provide multiple pathways of support, 12-Step, alternatives to 12-Step, and family support, recognizing the varied needs of our recovery community.

Overview - The proposal is to host one peer-led support group per week, following a monthly rotation model that includes:

Week 1 – 12-Step Group One of the following:

- Alcoholics Anonymous (AA)
- Narcotics Anonymous (NA)
- Dharma Recovery

Week 2 – Alternatives to 12-Step Groups One of the following:

- Women For Sobriety (WFS)
- Celebrate Recovery
- SMART Recovery

Week 3 – Support Groups for Families One of the following, rotating or as needed:

- Al-Anon
- Nar-Anon
- Alateen

Week 4 – Open or Repeating Week

- Optional use as a floating week for:
 - A repeat of any of the above based on demand
 - A guest speaker or workshop
 - A wellness night (e.g., meditation, art therapy, trauma-informed yoga, etc.) This cycle would repeat monthly, providing variety while maintaining a predictable structure.

Facilitation - To maintain consistency and safety in group facilitation, it is requested that:

- One FORA staff member volunteers to attend and run one group per month (not weekly).
 - Each staff volunteer would commit to a minimum term of six (6) months to promote continuity and relationship-building with participants.
- Staff would be the Peer facilitators who would lead the group content, support, oversight, and logistics. Benefits
- Multiple recovery pathways: Increases access to both traditional and alternative forms of support.
- Inclusion of families: Recognizes the role of loved ones in the recovery journey.
- Flexibility: Allows for responsive scheduling based on attendance and interest.
- Empowerment through peer leadership: Encourages community ownership and engagement.
- Low cost, high impact: Utilizes existing community resources and volunteers.

Logistics

- Time & Day: Mondays or Thursdays 7-8pm
- Location: Purple Room or other suitable on-site space
- Start Date: November 2025
- Marketing: Flyers, FORA website, peer networks, community calendars, 211 and United Way

Next Steps

- Approve proposal and assign staff coordinator
- Confirm initial 3-month schedule of groups
- Launch promotional efforts and outreach

Conclusion

This proposal aims to create an ongoing, inclusive support group structure at FORA that reflects the diversity of recovery experiences in our community. Through a rotating model of peer-led groups and minimal staff involvement, we can provide reliable support, increase

community engagement, and empower individuals to sustain their recovery journey. This goes hand and hand with saving ONE life at a time!






